This is a bibliography of literature pertaining to medieval logical theories of *obligationes*. The focus is primarily editions of treatises on *obligationes* and articles and books which have these as their specific focus, but I have also included some more general resources which include discussions of *obligationes*. I have tended to omit references which refer to *obligationes* only once in a throwaway manner.

The entries are ordered by publication date, from the least recent to the most, with unpublished and forthcoming entries at the end.
